## A BILL

To congressionally designate the museum to preserve the stories, knowledge, and history of the Medal of Honor to be constructed in Mount Pleasant, South Carolina, as the National Medal of Honor Museum.

1       *Be it enacted by the Senate and House of Representa-  
2       tives of the United States of America in Congress assembled,*

3       **SECTION 1. NATIONAL MEDAL OF HONOR MUSEUM.**

4       (a) FINDINGS.—Congress make the following find-  
5       ings:

6                   (1) The Medal of Honor Museum to be located  
7       in Mount Pleasant, South Carolina, will be the only

1 museum in the United States that exists for the ex-  
2 clusive purpose of interpreting the story of the  
3 Medal of Honor and all of the recipients of the  
4 Medal of Honor.

5 (2) The Medal of Honor Museum will be the  
6 only museum dedicated for the purpose of educating  
7 a diverse audience about the Medal of Honor  
8 through its collection of artifacts, photographs, let-  
9 ters, documents, and first-hand personal accounts of  
10 Medal of Honor recipients and the wars in which  
11 they have served.

12 (3) The mission of the Medal of Honor Museum  
13 is to preserve and present the extraordinary stories  
14 of individuals who reached the highest levels of rec-  
15 gnition, “above and beyond the call of duty”, in  
16 service to the United States, to inspire current and  
17 future generations about the six ideals of the Medal  
18 of Honor, namely courage, commitment, integrity,  
19 citizenship, sacrifice, and patriotism, to help visitors  
20 understand the meaning and price of freedom and  
21 what it means to put service above self, and to serve  
22 as an education center that, through various pro-  
23 grams, reaches out across the country to further the  
24 Medal of Honor’s ideals among all Americans, espe-  
25 cially young people.

1                             (4) The Medal of Honor was established by an  
2                             Act of Congress in 1861 and is presented by the  
3                             President “in the name of Congress”.

4                             (5) The Medal of Honor is the highest award  
5                             for valor in action against an enemy force which can  
6                             be bestowed upon an individual serving in the  
7                             United States Armed Forces.

8                             (6) The Medal of Honor has been awarded to  
9                             heroes of all races and social classes, and recipients  
10                            represent all 50 States, the District of Columbia,  
11                            Puerto Rico, and Guam.

12                           (7) As of September 7, 2016, there have been  
13                            3,496 recipients of the Medal of Honor, of which 19  
14                            individuals were double recipients.

15                           (8) Since World War II, the vast majority of  
16                            the 874 Medals of Honor awarded for service in  
17                            World War II, the Korean War, and Vietnam were  
18                            awarded posthumously.

19                           (9) As of September 7, 2016, there are only 77  
20                            living Medal of Honor recipients, and they have an  
21                            average age of 71 years old, which creates an urgent  
22                            need to preserve the stories, artifacts, and achieve-  
23                            ments of these heros.

24                           (10) The United States has an urgent need to  
25                            preserve the stories, knowledge, and history of the

1       recipients of the Medal of Honor and to portray that  
2       history, and the courage, commitment, integrity, citi-  
3       zenship, sacrifice, and patriotism of the recipients of  
4       the Medal of Honor, for future generations.

5                 (11) The State of South Carolina has provided  
6       a site for the Medal of Honor Museum in Mount  
7       Pleasant, South Carolina, at Patriot's Point on the  
8       eastern shore of Charleston harbor, not far from the  
9       site at which Sergeant William H. Carney of the  
10      Union Army's 54th Massachusetts Infantry Regi-  
11      ment became the first African-American recipient of  
12      the Medal of Honor as a result of his heroic actions  
13      on July 18, 1863, during the Battle of Fort Wagner.

14                (12) The Congressional Medal of Honor Society  
15      has designated this site as the location of the Na-  
16      tional Medal of Honor Museum, and the National  
17      Medal of Honor Museum Foundation is a nonprofit  
18      educational foundation established to design, fund,  
19      build, and maintain the museum.

20                (13) The Medal of Honor Museum receives  
21      funding support from the State of South Carolina  
22      and is now in the construction design and funding  
23      stage.

24                (14) The Medal of Honor Museum will become  
25      the premier museum of the Medal of Honor, its re-

1 cipients, and their stories, and a place where people  
2 will come to learn about Americans' experiences dur-  
3 ing critical periods in United States history and  
4 where the history of American struggles against ag-  
5 gression by would-be oppressors is preserved so that  
6 future generations can understand the role the  
7 United States continues to play in the preservation  
8 and advancement of democracy and freedom.

9 (b) DESIGNATION.—In light of the findings contained  
10 in subsection (a), the Medal of Honor Museum to be lo-  
11 cated in Mount Pleasant, South Carolina, is hereby des-  
12 ignated as the “National Medal of Honor Museum”.
